The construction allows equal performance at up to half the price of competitive Soft Discs The 10mm interface allows the sanding disc to follow the line of curved and irregular surfaces, rather than cutting into a change in shape. The pad allows machine sanding to be used, where previously hand sanding would have been employed. This gives a better finish in less time.

## Instructions

- 1. Select the required interface pad to suit the job.
- Apply to the Sander backing pad, ensuring it is applied centrally, and with the dust extraction holes aligned with those on the backing pad.
- Apply the Abrasive Disc to the pad, ensuring alignment of extraction holes and start the machine.
- 4. When the sanding disc has reached the end of its life, remove and replace with a new disc
