Application

Graffiti-Off is a powerful ready-to-use product for a quickly and easily removal of graffiti, paint, varnish and adhesive residues from most common surfaces like metal, concrete, glass, brick, wood etc.

Instructions

- 1. The surface must be dry and free of coarse dirt.
- 2. Use plastic drop cloths or aluminum foil to protect surrounding areas.
- 3. Shake well before use, and occasionally during use.
- 4. Spray a generous coat onto affected area and leave on for 15 to 20 minutes.
- 5. On smooth surfaces, wipe with rag or use a scraper, then flush with water.
- 6. On rough surfaces, use a wire brush, then wipe surface with a rag and flush with water.

N.B.: May damage plastics or painted surfaces, if in doubt test a small sample area before use. In case of wrong application, the product can be deactivated with water.
