Instructions

1. Apply 1 – 2 coats from a distance of 15 - 20cm onto the UV-cured UV-Ultra Primer
2. Wipe with a clean, dry cloth immediately after application. Do not allow to dry!
3. After painting, turn the can upside down, spray the valve until for 3 seconds.

Hints & Tips

For 2 cans of UV Primer, 1 can of UV Cleaner is required.

Optimum application at 18° C - 25° C and a relative humidity from 40 - 60 %.
