Application

KENT Performance Compound 2 can be used on all automotive paint systems, including cellulose, single component and 2-pack acrylic clearcoats, MS / HS paint systems, ceramic clear coats, UV clear coats and waterborne clear coats. A specially formulated ultra fine compound designed to polish out paint imperfections on all paint finishes and residual swirl marks and holograms on dark coloured paint finishes. Does not hide imperfections with cosmetic oil but removes scratches completely. Contains lubricants, which assist in a smoother, easier running of the polishing pad without leaving a greasy film and extending life of foam mop. The non-spray formula is especially developed to be used without water reducing clean-up time.

The Performance range will achieve an excellent showroom finish:

Artificial light in showrooms will always show scratches underneath the polished surface.

Scratches underneath polished surface will cause light scattering; meaning less glossy finish.

Surfaces prepared with Performance products won't show any underneath scratches as these are polished out by the product.

Instructions

1. For best results use with KENT Compounding polishing pad. Machine speed: 1000 - 2000 rpm (no load). Possible Options are Lambswool (P/N 85920) for extra cut (P1500-P2000), orange foam pad (P/N 85924) for P3000 Swirl removal, black foam pad (P/N 85925) for Hologram removal.
2. Never use excessive compound. It completely removes nibs and fine flattening paint scratches if used with the lambswool pad,
3. On soft or sensitive paint or where heat build-up may be a problem, the addition of water mist to avoid any friction burn, particularly with new pads, may assist in the polishing process. But avoid using too much water.
4. Once a Polishing pad is activated with water, no additional water needs to be used once the pad has been impregnated with product.
5. For hand or machine application
