Instructions

1 : Pour complete dose of Petrol Valve Cleaner in vehicle fuel tank filled with at least 25 liters and a maximum of 50 liters gasoline

2 : During intervention maintain engine speed above 3500 rpm in order to properly clean and burn deposits which leave the engine

Advice : For more efficiency drive several highway trips (50-100 KM) with above 3500 rpm

Hints and Tips : It is far less expensive trying to solve the issue of clogged engine with an excellent curative additive such as Petrol Valve Cleaner than spending far more in labour costs to remove engine parts and clean them manually
